Statutory Revisions as a Result of House Bill 7029

House Bill 7029, codified as <u>Chapter 2016-237</u>, <u>Laws of Florida</u>, revises a number of Florida Statutes (F.S.) related to public schools. A <u>memorandum</u> to school district superintendents and finance officers providing summary information and available implementation technical assistance was released on June 17, 2016.

Best Practices for Inclusive Education

Best Practices for Inclusive Education (BPIE) is a district-level self-assessment tool and process to identify and prioritize areas of need for inclusive practices that enable all students with disabilities to achieve their highest potential. BPIE is based on work by experts in the field, best practice literature and peer-reviewed research. When implemented with fidelity, BPIE leads to the development of district improvement goals that increase effective inclusive practices in all schools.

Section 1003.57(1)(f), F.S., requires each district and school to complete a BPIE assessment every three years. The Florida Inclusion Network provides support for the implementation of BPIE and related improvement goals in all Florida districts. K-20 Career and Education Planning System

The Florida career and education planning system, MyCareerShines, is available for the 2016-2017 school year. MyCareerShines will continue to help districts meet the requirements of <u>s. 1003.4156, F.S.</u>, which mandates that students complete a course in career and education planning in the middle grades. Students can use the system to explore their interests in associated careers, review educational requirements for various careers, build a career and education plan and search financial aid opportunities.

MyCareerShines offers a tool for secondary students, Navigator, and a separate tool for postsecondary and adult education students, Journey.

Several enhancements to MyCareerShines are planned for the 2016-2017 school year including:

- Spanish versions
- Templates for personalized education planning
- A parent portal
- Galaxy, an online education and career planning tool for elementary school students

Professional Practices Services

In March 2016, the State Board of Education approved significant revisions to the Principles of Professional Conduct and repealed the Code of Ethics. As of March 23, 2016, Rule 6A-10.081, Florida Administrative Code (F.A.C.), defines both ethical principles and disciplinary principles. Districts should review and update policies that referenced the former rule(s).

Visit www.myfloridateacher.com for information on statutory requirements related to investigating and reporting educator misconduct. This website includes information on an educator's obligation to report abuse and educator misconduct, links to the required employment screening tools and the form for public school districts, charter schools, or private schools that accept scholarship funds to report educator misconduct to FDOE. Site-level administrators are encouraged to familiarize themselves with this website and the investigative process as they may have communication with the Office of Professional Practices during the school year.

At www.myfloridateacher.com, on the Search Disciplinary Actions page, is a publicly accessible web search for disciplinary actions against a Florida educator's state-issued certificate. Florida law requires this website be searched prior to hiring instructional personnel or school administrators; however, districts should consider using this tool to vet all potential employees. Florida law prohibits a person from teaching or other employment requiring direct student contact in any Florida public school if the person's certificate is suspended or revoked.

<u>Section 1012.315, F.S.</u>, provides a list of offenses for which, if convicted, a person is ineligible for educator certification, and instructional personnel and school administrators as defined in <u>s. 1012.01, F.S.</u>, are ineligible for employment in a district school system, charter school or private school that accepts scholarship funds.

Districts that use third-party providers for their substitutes and virtual education providers must implement procedures to verify these persons are not prohibited from employment due to disqualification and/or suspension or revocation of a Florida educator certificate. The www.myfloridateacher.com website also provides a link to the hearings of the Education Practices Commission. Check this website regularly to view upcoming agendas.

Dual Enrollment

- The 2016-2017 <u>Dual Enrollment Course—High School Subject Area Equivalency List</u> has no changes from the 2015-2016 list.
- The <u>Dual Enrollment Frequently Asked Questions</u> (FAQ) document has been updated.
- House Bill 837 (<u>Chapter 2016-137, Laws of Florida</u>) made several important revisions to the establishment and content of dual enrollment articulation agreements.
 - All 2016-2017 dual enrollment articulation agreements must include a description of services and resources that are available to students with disabilities.
 - Articulation agreements between public postsecondary institutions and districts must still be submitted to FDOE by August 1. An updated agreement template is located at www.fldoe.org/core/fileparse.php/5421/urlt/0078396-dualanrollmentarticulationagreement.pdf.
 - o If a district has entered into a dual enrollment articulation agreement with a private postsecondary institution eligible to participate in dual enrollment pursuant to <u>s. 1011.62(1)(i)</u>, <u>F.S.</u>, that agreement must be submitted to FDOE by August 1 of each year.
 - o Pursuant to <u>s. 1007.271(22)</u>, <u>F.S.</u>, FDOE has developed an electronic submission system for all articulation agreements developed under <u>s. 1007.271(21)</u>, <u>F.S.</u> The submission website is being updated and will be available at <u>www.fldoe.org/policy/articulation</u>.

Career and Professional Education (CAPE) Information

The CAPE Industry Certification Funding List includes the following categories:

- CAPE Industry Certifications Industry certifications that do not articulate for college credit or do articulate for up to 14 college credits based on a statewide articulation agreement.
- CAPE Acceleration Industry Certifications Industry certifications that articulate for 15 or more college credits based on a statewide articulation agreement.
- CAPE Digital Tool Certificates Certificates available to elementary and middle grades students where a student must pass an assessment of digital skills in the following areas: word processing; spreadsheets; sound, motion and color presentations; digital arts; and cyber security to earn the certificate.

CAPE Innovation Courses: These courses combine academic and career performance outcomes with embedded industry certifications and must incorporate at least two third-party assessments, one of which must be associated with an industry certification on the CAPE Industry Certification Funding List.

Currently, the approved courses involve the pairing of an industry certification with an Advanced Placement (AP) course. The approved courses contain the current College Board AP course descriptions and require AP teachers to deliver a series of activities that emphasize applied learning of the AP content while learning new knowledge and skills associated with CAPE industry certifications. Districts are eligible for additional 0.3 full-time equivalent (FTE) membership in the Florida Education Finance Program (FEFP) for each certification earned. Students enrolled in AP courses cannot generate funding under both sections of the statute.

- Teacher bonuses shall be paid for CAPE Industry Certifications, CAPE Acceleration Industry Certifications and CAPE Innovation Courses.
- Elementary and middle grades students will be included in the 2016-2017 FEFP calculation up to a maximum of 0.1 FTE.
- The 2016-2017 General Appropriations Act designated \$4.5 million as performance incentive funds
 for the attainment of postsecondary industry certifications in district workforce education programs.
 There are multiple occupational areas in which students can earn industry certifications in order for
 the district to receive these funds. The legislation also designated that any funds not distributed to
 districts for industry certifications shall be distributed for adult education programs.

New Computer Science Standards

The State Board of Education adopted a computer science body of knowledge to be added to the existing Next Generation Sunshine State Standards for science at its May 20, 2016, meeting. These new standards establish the vision and framework for K-12 computer science content in Florida.

The new standards are available on <u>CPALMS</u>. Districts may submit for approval new course descriptions or existing course description revisions using these standards. Art in the Capitol Competition

House Bill 701 creates the Art in the Capitol Competition (<u>s. 1003.49965, F.S.</u>), a statewide visual arts competition for all students in grades 6-8. The winning selection from each district will be on display at the Capitol during each Florida legislative session. A <u>memorandum</u> was sent out June 10, 2016, with more information.

The timeline for the 2016-2017 Art in the Capitol Competition is as follows:

- Fall 2016 Districts will hold the annual Art in the Capitol Competition for all students in grades 6-8.
- January 6, 2017 The winning selection from each district shall be given to the legislator of the legislative district in which the student resides.
- March 7, 2017 The start of the regular session is the opening date of exhibit at the Capitol.
- May 5, 2017 The last day of the regular session is the end of the exhibit at the Capitol. Each legislator will return the winning submission from his/her district to the student after this date.

Updates to the Character Education Requirement

House Bill 1147 updates <u>s. 1003.42(2)(s)</u>, <u>F.S.</u>, to require that "the character-development curriculum for grades 9-12 shall, at a minimum, include instruction on developing leadership skills, interpersonal skills, organization skills, and research skills; creating a résumé; developing and practicing the skills necessary for employment interviews; conflict resolution, workplace ethics, and workplace law; managing stress and expectations; and developing skills that enable students to become more resilient and self-motivated." The course <u>Leadership Techniques</u> (#2400310) has been revised so that it meets all the requirements of this new legislation, and districts may use it if they choose. The way this requirement is met is a local decision. Human Trafficking Fact Sheet

Human trafficking involves exploiting a person through force, fraud or coercion for the purpose of forced labor and/or commercial sex. Victims of human trafficking include men, women, boys, girls and transgender individuals. Child human trafficking applies to persons under the age of 18. If the sex trafficking victim is under the age of 18, it is human trafficking regardless of whether force, fraud and/or coercion exist. Mandatory Child Abuse and Neglect Reporting and Training

<u>Chapter 39, Laws of Florida</u>, protects children from abuse and neglect and also provides a central registry to report suspected incidents. <u>Section 39.201(1)(a), F.S.</u>, states that school teachers and all school personnel are legally obligated to report any suspected abuse and neglect. Any school professional failing to report or preventing others from reporting is guilty of a felony of the third degree and may be prosecuted.

All teachers in grades K-12 are required to participate in continuing education training provided by the Florida Department of Children and Families (DCF) on identifying and reporting child abuse and neglect pursuant to <u>s. 1012.98(12), F.S.</u> It is important for new and returning teachers to complete the training on DCF's website at <u>www.myflfamilies.com/service-programs/abuse-hotline/training</u>.

The <u>Child Abuse Prevention Sourcebook for Florida School Personnel</u> is available to provide additional information and resources for school-based personnel.

Support for Instruction of English Language Learners

On May 20, 2016, the State Board of Education approved Rule 6A-6.0903, F.A.C., which establishes new exit criteria for English Language Learners (ELLs). Based on the ACCESS for ELL 2.0 assessments, students in grades 3-12 obtaining a composite proficiency score of 5.0 with no domain less than 4.0 and a satisfactory score on the Florida Standards Assessment-English Language Arts (FSA-ELA) may by exited from the English for Speakers of Other Languages (ESOL) program. Qualifying SAT and ACT scores may be used in lieu of the FSA-ELA score. K-2 students can also exit with an ACCESS for ELL 2.0 composite score of 5.0, with no domain less than 4.0. No other assessment is necessary. Schools and districts are to use the last day of the school year as the exit date for reporting purposes.

Implementing the English Language Development (ELD) standards into teacher lesson plans can only help improve instruction and ensure Florida's ELLs have equal access to career and college opportunities. FDOE recommends that teachers include the appropriate ELD standard into current lesson plans as part of the learning objectives and then indicate strategies to meet those objectives.

An example of a lesson plan objective for course M/J Grade 6 Mathematics (#1205010) could look like this:

- MAFS.6.EE.1.1 Write and evaluate numerical expressions involving whole-number exponents
- ELD.K12.ELL.MA.1 English language learners communicate information, ideas and concepts necessary for academic success in the content area of Mathematics
- ESOL Strategies:

Use manipulatives, bilingual dictionary, peer grouping, extra time*

*A more detailed use of strategies/vocabulary based on an ELL's individual English proficiency levels is recommended to tailor instructional needs.

Credit Acceleration Program

There are two new options:

- A student is allowed to earn high school credit in courses required for high school graduation without the requirement of enrolling in or completing the course through the passage of:
 - o An Advanced Placement (AP) examination
 - o A College-Level Examination Program (CLEP) examination
- Continuing option:
 - A student may earn high school credit in Algebra 1, Algebra 2, Geometry, U.S. History or Biology 1 if the student passes the statewide, standardized end-of-course (EOC) assessment without the requirement of enrolling in or completing the course.

Please note: the award of high school credit under the Credit Acceleration Program (CAP) for completion of an examination under the AP program or the CLEP is limited to the appropriate courses and credits listed in the K-12 <u>Course Code Directory</u>. While students will also earn college credit upon entrance to a postsecondary institution for passing scores on these examinations, that college credit may not also be applied as additional credit for high school graduation in addition to the secondary credit awarded under the CAP.

The award of college credit for examinations is described in <u>s. 1007.27, F.S.</u>, which states that credit by examination is the program through which secondary and postsecondary students generate postsecondary credit based on the receipt of a specified minimum score on nationally standardized general or subject area examinations. The award of college credit described in the <u>Articulation Coordinating Committee Credit-by-Examination Equivalencies</u> applies only upon entrance to a postsecondary institution; this award of credit does not also grant high school credit (e.g., students who pass the AP English Language and Composition examination with a score of 4 or 5 will be awarded credit for ENC 1101 and ENC 1102 only upon entrance to a postsecondary institution).

Finally, while the <u>Dual Enrollment Course</u>—<u>High School Subject Area Equivalency List</u> grants high school credits for completion of college courses, this applies to completion of the courses only. For example, students who complete ENC 1101 and ENC 1102 through dual enrollment will receive 1.0 credit each of high school credit, but this applies only for successful completion of the college courses through dual enrollment, not through an examination.

Online Course Requirement

A student has been able to satisfy the online course requirement for high school graduation by completion of one course via online learning. There are two new options for meeting this requirement:

- Completion of a course in which a student earns a nationally recognized industry certification in information technology or passage of the information technology examination without enrollment in or completion of the course
- Passage of an online content assessment by which the student demonstrates skills and competency in locating information and applying technology for instructional purposes without enrollment in the corresponding course or courses.

Florida Seal of Biliteracy Program

Beginning with high school graduates in the 2016-2017 school year, this program is established to provide high school graduates with recognition that they have achieved biliteracy, the attainment of a high level of competency in listening, speaking, reading and writing in one or more world languages in addition to English. Qualifying high school graduates will have an insignia on their diploma and a notation on their high school transcript as either a Gold Seal of Biliteracy (highest level of competency) or a Silver Seal of Biliteracy (second-highest level of competency), awarded by the Commissioner of Education.

To qualify, 2016-2017 high school graduates must:

- Earn four world language course credits in the same world language (3.0 grade point average on a 4.0 scale is required);
- Achieve a qualifying score on a world language assessment; or
- Satisfy alternative requirements as determined by the State Board of Education.

An administrative rule will go before the State Board of Education to establish the requirements to implement this program in accordance with s. 1003.432, F.S.

School Entry Immunization Requirements

Before attending school in Florida (grades K-12), each child must provide a Florida Certification of Immunization (DH 680 form) documenting specific vaccinations.

Assessments

Postsecondary Education Readiness Test (PERT)

- PERT will continue to be available throughout the 2016-2017 school year to administer as a collegeready assessment.
- PERT will be available at the current price per unit for districts to purchase at their own expense directly from McCann Associates.
- Districts will continue to have local flexibility with administering PERT by setting their own testing dates, retake policies and postsecondary preparatory course placement decisions.
- The five college readiness/success courses linked to college readiness cut scores are a required provision in the Student Progression Plan [s. 1008.25(2)(a), F.S.]. The five courses are included in the Course Code Directory and on CPALMS. Districts and schools should make local decisions in the best interest of each student regarding college and career readiness course enrollment and instructional support for success.
- A PERT Mathematics score of 97 will continue to be used as a comparative passing score for students to meet the Algebra 1 EOC assessment until a new comparative score is determined and adopted by the State Board of Education.

- Florida Standards Assessments (FSA)—Grades 3-10 English Language Arts (ELA); Grade 10 ELA Retake; Grades 3-8 Mathematics; and Algebra 1, Geometry and Algebra 2 EOC assessments
- Statewide Science Assessment—Grades 5 and 8
- Next Generation Sunshine State Standards (NGSSS) EOC assessments—Algebra 1 Retake, Biology 1, Civics, and U.S. History
- Florida Comprehensive Assessment Test (FCAT) 2.0 Reading Retake

Florida Kindergarten Readiness Screener – Work Sampling System

The Florida Kindergarten Readiness Screener – Work Sampling System (FLKRS-WSS) will be used for the 2016-2017 school year to fulfill the legislative requirement for assessing kindergarten readiness. A 2016-2017 Work Sampling System online module is available at

ACCESS 2.0 English Language Acquisition Assessment

Florida continues to partner with the WIDA consortium to administer assessments aligned to Florida's ELD standards. Florida's English language proficiency assessments, ACCESS for ELLs 2.0 and Alternate ACCESS for ELLs, will be administered as paper-based tests for the spring 2017 administration. Practice materials and additional information about the assessment will be provided this fall at www.wida.us/membership/states/Florida.aspx.

Districts will have access to the new WIDA Screener Online this fall, an English language proficiency screening tool that districts may use in evaluating and making placement decisions for incoming students. WIDA Screener Online is anticipated to become available in October 2016. In addition to the WIDA Screener Online, a paper version is now available for purchase from the WIDA Store at the Wisconsin Center for Education Products and Services (WCEPS). Information about WIDA Screener Paper is available at www.wceps.org/store/wida/. Districts may also continue to use WIDA-ACCESS Placement Test (W-APT) as another instrument to evaluate and make placement decisions for incoming students. Information about W-APT is available at www.wida.us/assessment/W-APT/.

The WIDA Measure of Developing English Language (MODEL) can be used as an identification/placement assessment for newly enrolled ELLs in grades K-12. MODEL is an adaptive test that can be administered at any time during the school year. Unlike ACCESS for ELLs, the WIDA Screener Online and the W-APT, districts will have to purchase the WIDA MODEL in order to evaluate and make placement decisions for incoming students. Florida Standards Alternate Assessment

In the spring of 2017, the Florida Standards Alternate Assessment (FSAA) program will consist of two pathways for assessing students with significant cognitive disabilities:

- FSAA—Performance Task, which was administered operationally for the first time in the spring of 2016.
- FSAA—Datafolio, which was developed in response to the need to support a small subset of students with the most significant cognitive disabilities who do not have an identified formal mode of communication and may be working at pre-academic levels. The Datafolio was piloted in 2015-2016 among a subset of Florida students with significant cognitive disabilities.

In addition to assessments in grades 3-10 for ELA, grades 3-8 in Mathematics, EOC assessments for Algebra 1 and Geometry aligned to Florida Standards-Access Points and assessments aligned to the NGSSS-Access Points in science (Grades 5, 8, and Biology 1 EOC assessment), the FSAA program will expand to include EOC assessments in Access Civics in middle school and Access U.S. History in high school, also aligned to the NGSSS-Access Points. Progress Monitoring and Reporting Network (PMRN)

New for the 2016-2017 school year, district-level users have the ability to register schools in their district as well as manage school-level users, students and classes. District-level users may also update student demographics and Exceptional Student Education eligibility for the FAIR-FS Modified Task Flow. The Coach's Log will not be available to record professional development activities for the 2016-2017 school year; however, Coach's Log reports for the 2014-2015 and 2015-2016 school years will be accessible through the system.
